AN ORDINANCE ACCEPTING 588 SQUARE FEET OF PERMANENT PARCEL NO. 07-00-028-101-053 ON THE NORTHWEST CORNER OF THE CENTER RIDGE ROAD AND STONEY RIDGE ROAD INTERSECTION AND DEDICATING IT FOR PUBLIC PURPOSES.

WHEREAS, the Talan Limited Liability Company has agreed to donate 588 square feet of Permanent Parcel No. 07-00-028-101-053 for the improvement of the Center Ridge Road and Stoney Ridge Road intersection; and

WHEREAS, said area is required to properly improve the intersection.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NORTH RIDGEVILLE, LORAIN COUNTY, OHIO, THAT:

SECTION 1. The city of North Ridgeville hereby accepts 588 square feet of the Southeast corner of Permanent Parcel No. 07-00-028-101-053 for the improvement of the Center Ridge Road and Stoney Ridge Road intersection, and hereby dedicates said area for public purposes.

SECTION 2. This Ordinance is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the health, safety and welfare of the Citizens of the City of North Ridgeville, Ohio by accepting 588 square feet of permanent parcel no. 07-00-028-101-053 on the northwest corner of the center ridge road and Stoney Ridge Road intersection and declaring it for public purposes in order to properly improve that intersection; WHEREFORE, this Ordinance shall take effect and be in full force and effect immediately upon its passage and approval by the Mayor..


