

AN ORDINANCE CHANGING THE NAME OF MEADOW STREET
IN SUMMERHILL SUBDIVISION NO. 2 TO WHITE PINES STREET
AND DECLARING AN EMERGENCY

WHEREAS, the Subdivider of Summerhill Subdivision No. 2 and others owning property on Meadow Street in the municipal corporation have, pursuant to Ohio Revised Code Section 723.04, petitioned for a formal change in the name of Meadow Street, as shown on the plat for Summerhill Subdivision No. 2, to White Pines Street in order to comply with the recommendation of Planning Commission.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON, LORAIN COUNTY, OHIO:

61 Section 1. That the street known as Meadow Street as shown in the plat for Summerhill Subdivision No. 2 recorded as Plat Volume 23, Page 89 at Lorain County Recorder's Office, is hereby changed to White Pines Street. 42

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the citizens of City of Avon, the immediate emergency being the necessity to comply with recommendation of Planning Commission and that the ordinance shall take effect and be in force immediately after passage and approval by the Mayor.

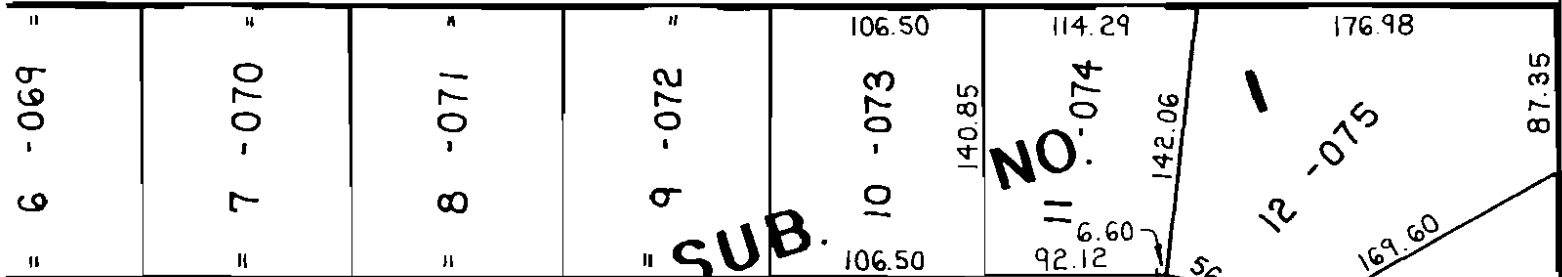

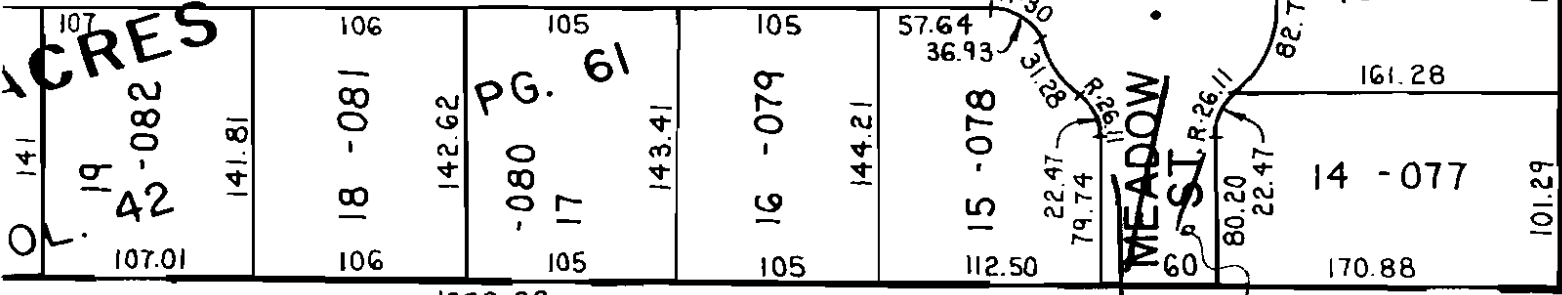

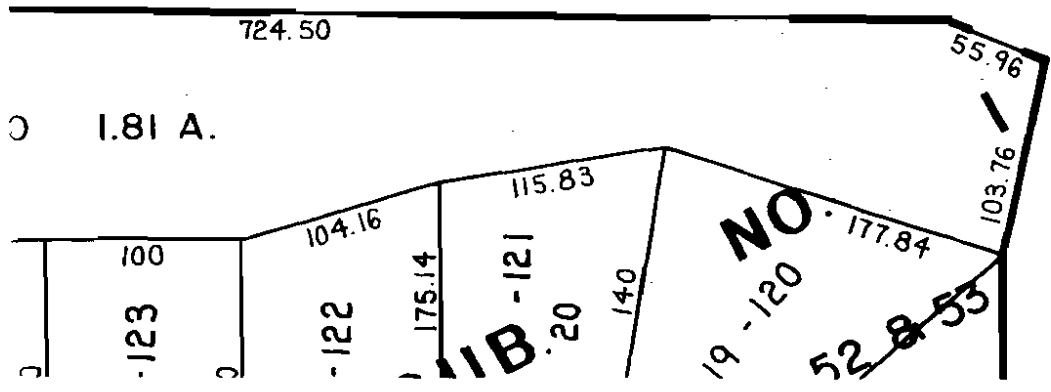
