

ORDINANCE NO. 55-73

AN ORDINANCE TO VACATE EAST 30TH COURT EXTENDING FROM THE WEST LINE OF VINE AVENUE TO THE EAST LINE OF FULTON ROAD, IN THE CITY OF LORAIN, OHIO.

WHEREAS, Council upon a public hearing, held APRIL 2nd 1973, under Section 723.04 and 723.07, Ohio Revised Code, is satisfied that there is good cause for the vacation of East 30th Court extending from the west line of Vine Avenue to the east line of Fulton Road, and that said street is no longer needed for municipal purposes, and should be vacated.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION I. That East 30th Street extending from the west line of Vine Avenue to the east line of Fulton Road, in the City of Lorain, Ohio, be and the same is hereby vacated, subject however, to the reservations that the City of Lorain, Ohio, reserves to itself and others, easement rights, to construct or maintain sewer lines, water lines, gas lines, telephone conduits, electric conduits, telephone and electric pole lines, and other similar facilities under, on, or above said street, whenever deemed necessary, by the City of Lorain. The easement rights stipulated above may be reduced to a more practical width upon accurate determination of the needs to satisfy existing and proposed utilities and to conform to the plans adopted by the City Council for Lorain Urban Renewal 'A', Project Ohio R-110.

SECTION II. That one half ($\frac{1}{2}$) of the width of said street shall revert to the abutting owners on each side of said street.

SECTION III. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
