WHEREAS, the City of Lorain's Sewer and Engineering Departments have established that there is no current or future requirement to use or maintain the Sanitary Sewer; and

WHEREAS, the attached easement is one of two easements previously established per Ord. 8584, which was repealed by Ord. No. 73-18 and contained an incomplete map.

NOW THERERFORE BE IT ORDAINED BY THE CITY OF LORAIN, STATE OF OHIO;

SECTION 1. That the 60' easement, located in the vicinity of Leavitt, Eastman and Williamsburg Heights First Addition in the City of Lorain, and as more fully described in Exhibit A and attached hereto, is abandoned and is no longer required for municipal use and is hereby vacated.

SECTION 2. That the Clerk of Council shall file the appropriate documentation with city and county offices to establish clarity.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken up in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Ohio Revised Code 121.22.


