ORDINANCE NO. 5828

An Ordinance vacating an alley South of East Erie Avenue and extending from Montana Avenue Westerly approximately one hundred fifteen (115) feet.

WHEREAS, on the 7th day of June, 1948, a petition by persons owning lots in the immediate vicinity of an alley South of East Erie Avenue and extending from Montana Avenue Westerly approximately one hundred fifteen (115) feet, was duly presented to Council, praying that said alley between the points named be vacated, and,

WHEREAS, Council, upon hearing, is satisfied that said petition contained 100 per cent of the signatures of the abutting property owners, and that there is good cause for such vacation as prayed for, and that it will not be detrimental to the general interest and ought to be made;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

- N 1. That the alley South of East Erie Avenue and extending from Montana Avenue Westerly approximately one hundred fifteen feet, be, and the same hereby is, vacated.
- N 2. The City Auditor is hereby directed to record the vacation of this alley with the Lorain County Auditor and the Lorain County Recorder's office in Elyria, Ohio.
- N 3. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
