WHEREAS, after due and legal advertising, this is the day fixed for the public hearing on the vacating of an alley running east and west from Olivet Avenue to Grace Avenue, between Northwood Street and Elmwood Street in Clearview Subdivision, Elyria Township, Lorain County, Ohio; and

WHEREAS, no objections were presented to said road vacation;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby vacate said alley, located in Elyria Township, Lorain County, Ohio, for which description is as follows:

Alley running east and west from Olivet Avenue to Grace Avenue between Northwood Street and Elmwood Street of the Clearview Subdivision located in Elyria Township, Lorain County, Ohio, also recorded in Volume 10, Page 8, of Lorain County Records.

Said property is to revert back to acreage of property owners along said alley, being 15 feet in width, and 7.5 feet will be added to lots bounding the alleyway.

FURTHER BE IT RESOLVED that certified copies of this resolution be furnished to the Lorain County Auditor, Recorder and Engineer for proper recording thereof.

The foregoing resolution was introduced upon a motion by Commissioner J. Norman Thompson, seconded by Commissioner James P. Horn and the vote taken thereon resulted as follows: J. Norman Thompson, "aye"; James P. Horn, "aye"; L. M. Pincura, "aye".

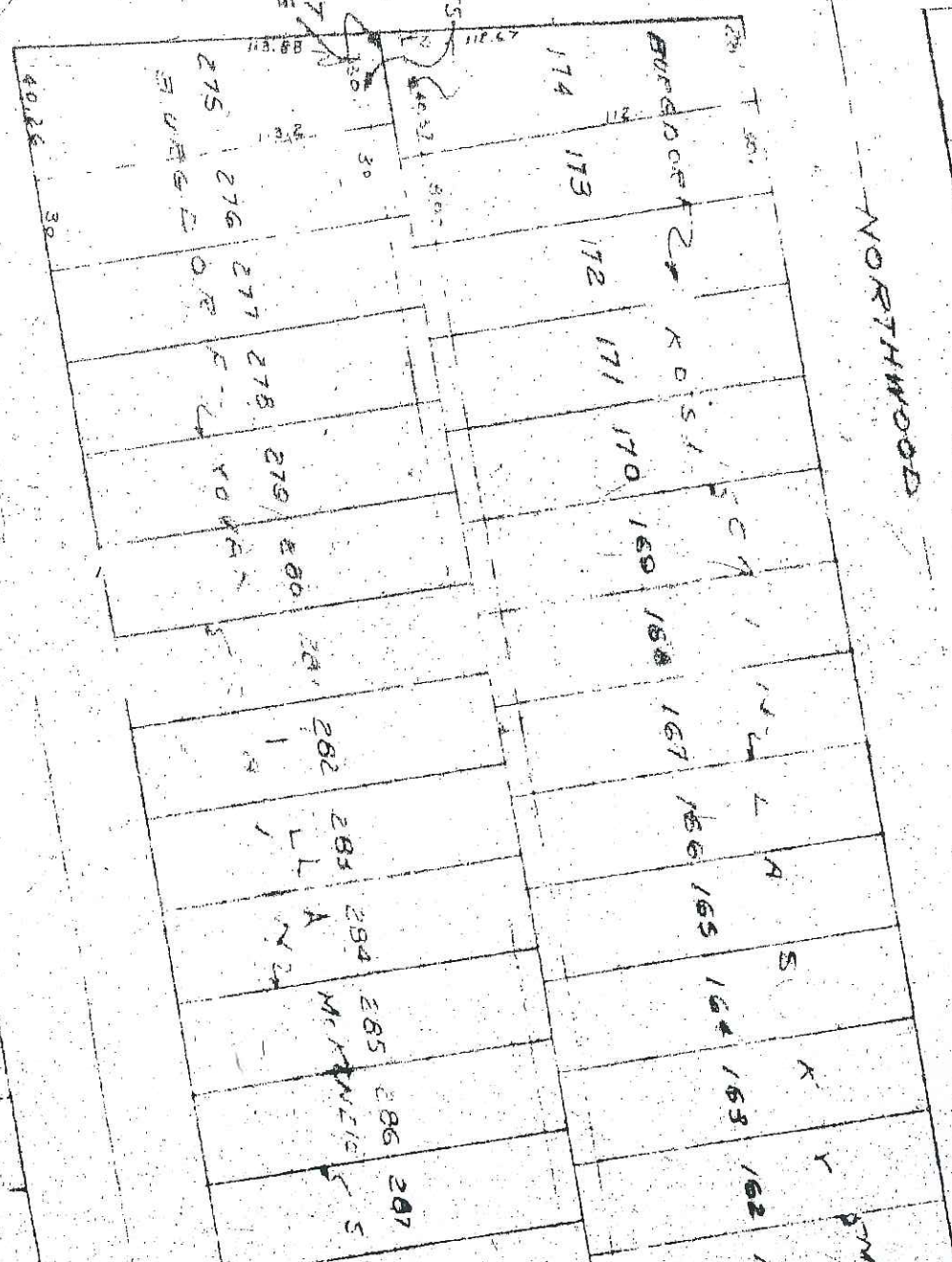
NEW PROPOSED LOT LINE BY VACATING ALLEYWAY
