AN ORDINANCE VACATING THOSE PORTIONS OF EAST BOULEVARD, THELMA DRIVE, GAYLE DRIVE, LYNNE DRIVE AND RICHELIEU AVENUE SOUTH OF WALKER ROAD AND GENERALLY EAST OF COVE BEACH AVENUE WHICH PORTIONS ARE MORE FULLY AND COMPLETELY DESCRIBED IN ATTACHED EXHIBIT "A" WHICH IS INCORPORATED HEREIN AND MADE A PART HEREOF AS IF FULLY SET FORTH HEREIN WITHIN THE CITY OF SHEFFIELD LAKE, OHIO AND THE DECLARING OF AN EMERGENCY.

WHEREAS, the publication of notice of the possible vacation of certain portions of East Boulevard, Thelma Drive, Gayle Drive, Lynne Drive and Richelieu Avenue South of Walker. Road and generally East of Cove Beach Avenue and which is more fully and completely described in attached Exhibit "A" and which portions are hereinafter sometimes referred to as Exhibit "A" has been completed pursuant to statute, and

WHEREAS, the Council of the City of Sheffield Lake, Ohio has determined that it is in the best interest of the City of Sheffield Lake, Ohio to vacate those portions of those streets described in Exhibit "A", and

WHEREAS, the vacation of those portions of those streets described in Exhibit "A" will not be detrimental to the general interest and welfare of the City of Sheffield Lake, Ohio,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO:

Section 1.

Those portions of East Boulevard, Thelma Drive, Gayle Drive, Lynne Drive and Richelieu Avenue South of Walker Road and generally East of Cove Beach Avenue within the City of Sheffield Lake, Ohio and more fully and completely described in attached Exhibit "A" which is incorporated herein and made a part hereof as if fully set forth herein are hereby vacated and shall no longer be public thoroughfare roads or streets within the City of Sheffield Lake, Ohio.

Section 2.

The foregoing vacation is however subject to reservation by the City of Sheffield Lake, Ohio of all easements necessary to provide for public utilities and services of a type and kind that may from time to time be at the sole and exclusive option of the City of Sheffield Lake, Ohio provided by the City of Sheffield Lake, Ohio and or its designees.

Section 3.
