RESOLUTION NO. 69-309

WHEREAS, the following petition is presented to vacate a portion of Portman Road in Henrietta Township, Lorain County State of Ohio:

Now comes Kenneth C. Rogal and respectfully represents that he is the lawful owner of the land abutting on both sides of the portion of the old Portman Road in Henrietta Township, Lorain County, Ohio, and being that part of O.L. Numbers 81 and 82 bounded and described as follows:

Beginning at the northeast corner of O.L. 81 Henrietta Township; thence South $1^{\circ} 33'$ West along the East line of O.L. 81 a distance of 30.02 feet to the place of beginning of land hereafter described; thence North $86^{\circ} 00'$ West a distance of 22.52 feet to the west line of Original Portman Road; thence South $1^{\circ} 33'$ West along the westerly line of the original Portman Road a distance of 232.51 feet to a point; thence South $80^{\circ} 27'$ East a distance of 45.44 feet to the easterly line of the Original Portman Road; thence North $1^{\circ} 33'$ East along the easterly line of the original Portman Road a distance of 236.91 feet to the southerly line of Portman Road; thence North $86^{\circ} 00'$ West a distance of 22.52 feet to the place of beginning and containing within said bounds about 0.24 acres of land be the same more or less.

Areas of Road vacated does not increase or decrease acreage as conveyed to Kenneth C. Rogal.

This description prepared by Arnold F. Koepf, Registered Surveyor No. 43.06 on April 6, 1968.

Said Kenneth C. Rogal further represents that the above described portion of the Portman Road was abandoned more than 21 years ago and has not been used as a public road for more than 21 years by reason of the fact that a new section of Portman Road was dedicated March 14, 1932, and thereafter the new portion of the Road was constructed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that in accordance with Section 5553.042 Revised Code of Ohio, you do and hereby approve and grant the vacation of Portman Road being 45' feet in width, and length further described in map attached to this petition, proceeding through property of Kenneth C. Rogal, and considered part of the whole of present property now owned by Kenneth C. Rogal. This action being
