ORDINANCE NO. 336

AN ORDINANCE CHANGING THE NAME OF CRITTENDEN STREET IN THE VILLAGE OF LAGRANGE TO PARK LANE STREET; AND DECLARING AN EMERGENCY.

WHEREAS, it will not be detrimental to the general interest, and there is good cause shown that the name of the following street be changed.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LAGRANGE, OHIO:

SECTION 1: That for good cause shown, the name of $Dr_1v \in Crittenden$ Street is and is hereby changed to Park Lane Street.

SECTION 2: That said name change is not detrimental to the general interest of the inhabitants of the Village of LaGrange, Ohio.

SECTION 3: That this ordinance is and is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public health, safety, and welfare by providing for the change in the name of a Village Street; wherefore, this Ordinance shall take effect and be in full force from and after its passage and approval.
