Minutes of La Grange Village Council

Meeting

Form No. 1002

Held July 16 1969

This was a regular meeting of the Council of the Village of La Grange, Lorain County, Ohio, and was called to order at 8:05 PM by Mayor Grabenstetter.

Roll call showed five members present. Behner, Johnson, Oppfer, Rahrig and Smith.

The minutes of the June meeting were read, approved and signed.

The budget for 1970 was read and discussed. Smith moved to accept the budget as read, seconded by Behner. Roll call:

Behner - yes, Johnson - yes, Oppfer - yes, Rahrig - yes, and Smith, yes.

Ordinance # 335, an ordinance authorizing the advertising of bids for resurfacing N. & S. Church streets was read. Behner moved to suspend the rules on Ord # 335 and adopt as an emergency, seconded by Smith. Roll call: Behner, yes; Johnson - yes, Oppfer - yes, Rahrig - yes, and Smith - yes.

Ordinance # 336, an ordinance to change the name of Crittendon St. to Park Lane Drive was read. Behner moved to suspend the rules on Ord. # 336 and adopt as an emergency, seconded by Rahrig. Roll call: Behner, yes, Johnson yes, Oppfer - yes, Rahrig - yes and Smith - yes.

ORDINANCE NO. 336

AN ORDINANCE CHANGING THE NAME OF CRITTENDEN STREET IN THE VILLAGE OF LAGRANGE TO PARK LANE ~~STREET~~ ^{Drive} AND DECLARING AN EMERGENCY.

WHEREAS, it will not be detrimental to the general interest, and there is good cause shown that the name of the following street be changed.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LAGRANGE, OHIO:

SECTION 1: That for good cause shown, the name of Crittenden Street is and is hereby changed to Park Lane ^{Drive} ~~Street~~.

SECTION 2: That said name change is not detrimental to the general interest of the inhabitants of the Village of LaGrange, Ohio.

SECTION 3: That this ordinance is and is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public health, safety, and welfare by providing for the change in the name of a Village Street; wherefore, this Ordinance shall take effect and be in full force from and after its passage and approval.
