In the matter of vacating an alley south of North Ridge Road between Olivet Street on the east and Grace Street on the west in Elyria and Sheffield Townhips, Lorain County, Ohio.

January 9,1969

WHEREAS, this is the day fixed for the public hearing on vacating an alley in Sheffield and Elyria Townships; and

WHEREAS, the Board of Commissioners did on June 4,1969 view the alley to be vacated; and

WHEREAS, nine interested citizens in addition to three board members, county engineer Harvey M. Holcomb and deputies Charles Waryu and Arnold Koepp along with Mr. Art Schaber, Elyria Township Trustee were present at this hearing; and

WHEREAS, there were four persons objecting out of the nine citizens present because of the water drainage problem;

WHEREAS, after an hour long discussion it was decided to proceed with the petition;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby approve the vacation of an alley being fifteen feet wide and proceeding parallel to and approximately one hundred twelve feet (112) South of North Ridge Road between Olivet Street on the East and Grace Street on the West in Elyria and Sheffield Townships, Lorain County, Ohio. Said street being 15 feet wide and shall be divided equally and accrue to the benefit of the adjoining property owners as defined on map attached to the petition and made a part hereof.

FURTHER BE IT RESOLVED by the Board of Commissioners that the auditor, recorder, and engineer receive certified copies of this resolution for the purpose of marking their records.

The foregoing resolution was introduced upon a motion by Commissioner Fred M. Ritenauer, seconded by Commissioner L. M. Pincura, and the vote taken thereon resulted as follows: Fred M. Ritenauer, "aye"; L. M. Pincura, "aye"; J. J. Keron, "aye ".

Motion carried.
