RESOLUTION NO. 69-609

In the matter of vacating an abandoned street )  
known as Wilbur Avenue in Elyria Township, by )

WHEREAS, the following petition was presented by Lorain Elyria Packing Company to vacate the following street in Elyria Township:

"To: The Board of Commissioners of Lorain County                      Petition to vacate Abandoned Township Road

The undersigned represents that it is the owner of parcels of land in the Township of Elyria, Ohio, which are in the immediate vicinity of and abut Wilbur Avenue.

The undersigned respectfully petitions your honorable body that said Wilbur Avenue be vacated between the <sup>west</sup> east line of Antrim Street westerly to the right of way of B & O Railroad at a distance of about 571.5, feet, the points set forth herein, for the reason that Elyria Township has abandoned said street and has not been used by the public for a period of 21 years or more. Said street being fifty (50) feet wide and shall be and accrue to the benefit of the adjoining owners as defined on the map attached to the petition and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that pursuant to Section 5553.042 and full authority invested therein, we do and hereby vacate Wilbur Avenue in Elyria Township, Lorain County, said street having been abandoned, and not in use for over twenty-one (21) years. Said right of way being 50 feet wide and shall accrue in its entirety, to property owners, Lorain Elyria Packing Company, which concern is owners of property described on the map known as lots nos. 61, 62, 63, 64, 65, 66, 67/68 on one side and lots nos 155, 154, 153, 152, 151, 150, 149, 148 located directly across. Said street is so ordered vacated by this Board of Lorain County Commissioners.

Further Be It Resolved that copies of this resolution be furnished the Lorain County Auditor, Engineer, and County Recorder for identification of their records.

The foregoing resolution was introduced upon a motion by Commissioner J. J. Keron, seconded by Commissioner L. M. Pincura, and the vote taken thereon resulted as follows: J. J. Keron, "aye"; L. M. Pincura, "aye"; Fred M. Ritenauer, "aye".
