In the matter of accepting a petition from )  
property owners along Cooper Foster Park )  
Road, east of Baumhart Road to change the )  
name of said road to "Whittlesey Road", and ) September 29, 1969  
instruct the Clerk to notify residents of )  
a public hearing regarding this matter, which )  
is to take place on October 8, 1969 in the )

WHEREAS, the following petition was presented to change the name of a road:

"September 9, 1969

We the undersigned, hereby petition The Brownhelm Township Trustees to restore the name of Whittlesey Road to that portion of old Cooper Foster Park Road, which is now dead-ended east of Baumhart Road. We proposed this renaming for three reasons, viz:

1. To eliminate confusion on the part of the travelling public
11. To honor the name of one of the earliest settlers of this area and for whom the County Courthouse Records show that it once was called Whittlesey Road
111. To avoid future confusion for Fire Departments, ambulances and the traveling public when the extension of said road is completed to North Ridge Road.
