AN ORDINANCE ACCEPTING THE PLAT OF EDGEWOOD
ESTATES SUBDIVISION NO. 7 (A RE-SUBDIVISION
OF BLOCK 'A' OF ORIGINAL EDGEWOOD ESTATES
SUBDIVISION NO. 2) TO THE CITY OF LORAIN, OHIO

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF
OHIO:

SECTION 1. That the plat of Edgewood Estates Subdivision No. 7
(a re-subdivision of Block 'A' of original Edgewood Estates
Subdivision No. 2) (Lots 160 through 204 both inclusive) in the
City of Lorain, be and the same is hereby approved. The streets
shown thereon; namely, Redbud Court, Wysteria Drive, Summerly
Drive and Lindenwood Court, be and the same are hereby accepted.

SECTION 2. That this Ordinance shall take effect and be in force
from and after the earliest period allowed by law.
