AN ORDINANCE TO VACATE PORTIONS OF NORTH AND SOUTH DRIVES IN THE ARBOR LAND COMPANY'S WOODHAVEN BEACH SUBDIVISION NO. 1.

WHEREAS, notice of the pendency and intent of this Ordinance has been given as required by law by publication in the Lorain Journal, a newspaper of general circulation in the City, for six consecutive weeks ending on November 2, 1964; and

WHEREAS, Council, upon hearing, is satisfied that there is good cause for vacation, as proposed, of the southerly twenty-five feet of South Drive and the northerly twenty-five feet of North Drive in the Arbor Land Company's Woodhaven Beach Subdivision No. 1 in the general vicinity of Forest Hill Drive and Herrmann Drive; that said portions of South Drive and North Drive are no longer required for public purposes; that it will not be detrimental to the general interest and ought to be made;

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF AVON LAKE, STATE OF OHIO:

Section No. 1: That the southerly twenty-five feet (25') of South Drive and the northerly twenty-five feet of North Drive for their full length in the Arbor Land Company's Woodhaven Beach Subdivision No. 1 in the general vicinity of Forest Hill Drive and Herrmann Drive, be and the same are hereby vacated.
