ordinance no. 76.78

An Ordinance granting to the Lorain-Elyria Sand Company a permit to construct an extension of the dock on the easterly side of Black River, along the westerly line of said company's property fronting Black River.

WHEREAS, Council did by Ordinance No. 7489, passed on the 4th day of November, 1957, grant to the Lorain-Elyria Sand Company a permit for the construction of a dock commencing at the northerly line of said company's property along the easterly side of Black River, and extending a distance of 200 feet southerly, and

WHEREAS, the Lorain-Elyria Sand Company, pursuant to said authority, did construct said dock and now desires to extend said permanent dock a distance of approximately 800 feet along the proposed new dock line to the southerly boundary line of said company's property, and

WHEREAS, said company has secured a permit from the federal authorities authorizing the construction of said extension of dock facilities, and

WHEREAS, a permit from the City of Lorain is desired by said company to extend present dock line facilities;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

That a permit shall be and hereby is granted to the Lorain-Elyria Sand Company to extend their present dock facilities from the present terminus of the dock, which point is 200 feet southerly from its northerly boundary line, in a southerly direction, a distance of approximately 800 feet to the southerly boundary line of said company's property, fronting on the east side of Black River.

This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of Lorain and for the further reason that the immediate granting of such permit is urgently required so as to provide for the effective, proper and orderly development of river front property along the easterly side of Black River.

That this ordinance shall take effect and be in force from and after its passage by law.
