vote taken thereon resulted as follows: J. J. Keron, "aye"; Fred M. Ritenauer, "aye"; Alan J. Zaleski, "aye".

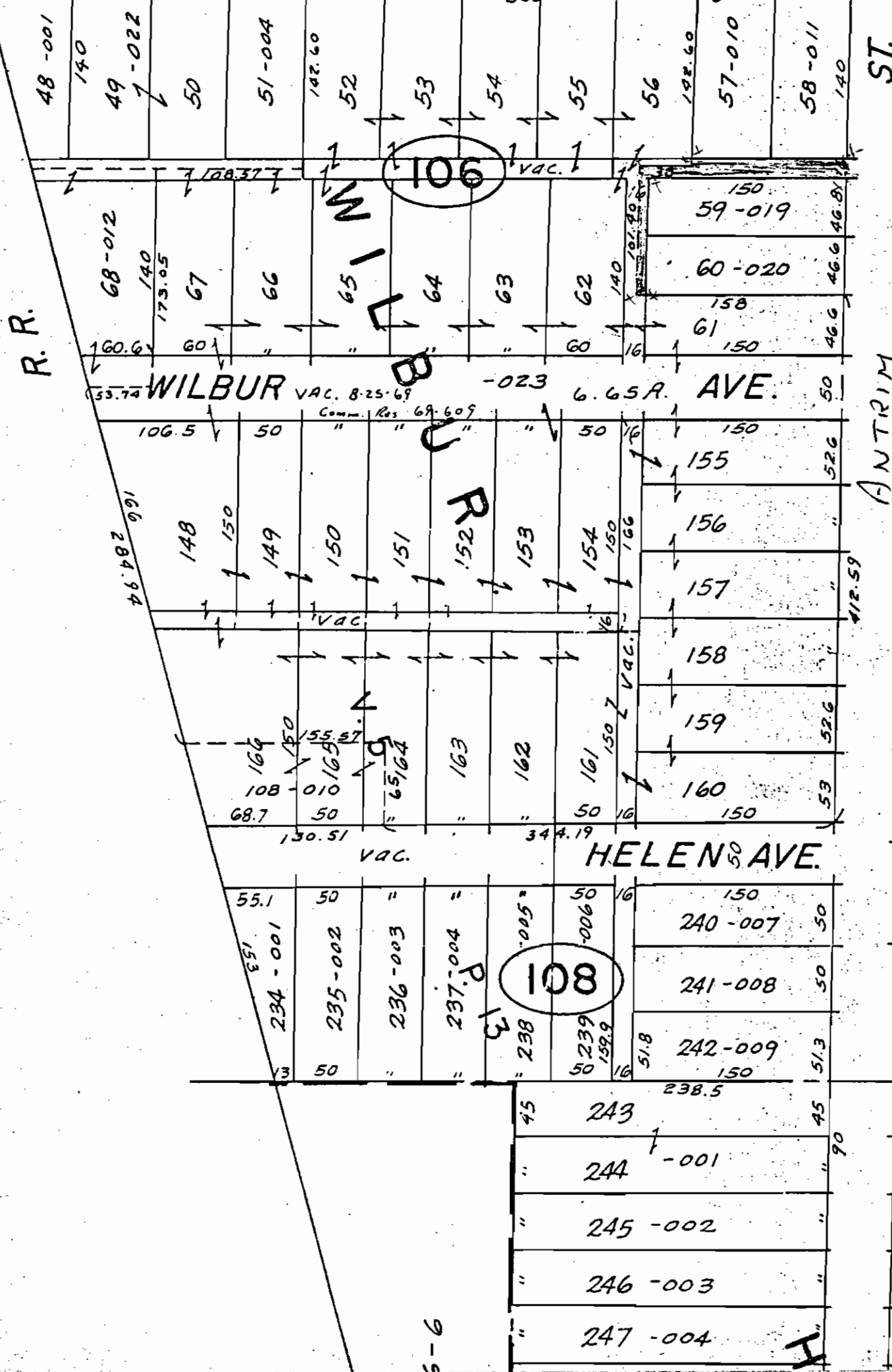
