ORDINANCE NO. 77-98

AN ORDINANCE ACCEPTING FOR DEDICATION THE PLAT OF WIND ESTATES, AND DECLARING AN EVERGENCY

WHEREAS, there has been submitted to the Council a Plat of Wind Estates in the City of Elyria, Ohio; and,

WHEREAS, the City Planning Commission granted final approval to the plat on July 5, 1977 and,

WHEREAS, the owner, Dale Yost Construction Company has fully complied with the requirements of Title Three, Chapter LLL through Chapter 1119 of the Codified Ordinances of the City of Elyria, Ohio, covering the acceptance of Allotments by the City of Elyria;

NOW, THEREFORE, BE IT CADAINED BY THE COUNCIL OF THE CITY OF ELYRIA, STATE OF OHIO:

SECTION 1: That the Council does hereby accept the Plat of Wind Estates, and dedication of Deerfield Court, and essements for City. umed utilifies as shown thereon, and as submitted to this Council.

SECTION 2: That the bond of Dale Yest Construction Company heretofore filed with the City Engineer and approved by him as to the amount and approved by the City Law Director as to form, in the amount of Three Hundred Fifty Thousand Dollars (\$350,000.00) to secure the installation of pavement, storm sewer, sanitary newer, water main and sidewalks as shown on the improvement plans now on file in the City Engineer's Office, is approved and accepted as securing the installation of such improvements to serve the lots of said subdivision.

SECTION 3: That upon passage of this Ordinance, the Clerk of Council shall certify a copy of same to the Lorain County Recorder for indication that said plat may be accepted by the Recorder.

SECTION 4: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5: That this Ordinance is and is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public peace, health and safety of the people of the City of Elyria. Ohio, by providing for the acceptance of the Plat of Wind Estates, and dedication of Windbrook Court, Deerfield Court, and essements for City-owned utilities as shown therein; wherefore, this Ordinance shall take effect and be in force from and after its passage and approvel.
