AN ORDINANCE ACCEPTING A DEDICATION PLAT FOR A CERTAIN PORTION OF GUILFORD ROAD BEING A STRIP 20 FEET WIDE BY 194.31 FEET IN LENGTH AT THE INTERSECTION OF LIBERTY AVENUE AS SUBMITTED BY THE SITE AND TRACK REAL ESTATE COMPANY; DULY DEDICATING SAID PORTION OF ROADWAY AS A PUBLIC THOROUGHFARE OF THIS CITY; AUTHORIZING APPROPRIATE CITY OFFICIALS TO AFFIX THEIR ENDORSEMENT THEREUPON AS HAS BEEN FAVORABLY RECOMMENDED BY PLANNING COMMISSION; AND DECLARING AN EMERGENCY.

WHEREAS, Vermilion City Planning Commission did favorably recommend here upon on September 28, 1978; and

WHEREAS, the City Engineer has advised this Council that it is in the best public interests to dedicate an additional portion of Guilford Road;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Vermilion, Counties of Erie and Lorain, State of Ohio:

SECTION 1: That a dedication plat submitted by the Site and Track Real Estate Co. under date of August 22, 1978, prepared by Neff and Associates, consulting engineers and surveyors of Cleveland, Ohio, dedicating a certain portion of Guilford Road at the intersection of Liberty Avenue, being a strip 20 feet in width and 194.31 feet in length, be and the same is hereby accepted by this City Council. That the appropriate city officials, being the Mayor, the Clerk of Council, the City Engineer, and appropriate member of the Planning Commission be and they hereby are authorized to endorse their signatures thereupon. That the same shall be recorded in the Offices of the Recorder of Lorain County, Ohio.

SECTION 2: That said portion of Guilford Road as depicted upon the plat referred to in Section 1 hereof, all of which, including said plat, is incorporated herein by this reference, be and the same is hereby accepted as a duly dedicated street and portion thereof of the City of Vermilion, Ohio open to the public access and under control of the City.

SECTION 3: That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and welfare of the City, for the reason that it is in the general public interest that said portion of Guilford Road become dedicated as a public highway of this City in accordance with the favorable recommendations of the City Engineer and City Planning Commission; and provided it receives the majority vote of two-thirds or more of those elected or appointed to City Council, it shall go into full force and effect from and immediately after its passage and its approval by the Mayor; otherwise it shall take effect at the earliest period allowed by law.
