AN ORDINANCE VICATING A PORTION OF AN ALLEYWAY ON WEST RIVER ROAD AND 49TH STREET, OUTSIDE THE RIGHT OF WAY LINE MEEDED FOR THE WIDENING OF WEST RIVER ROAD, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ELYRIA, STATE OF CHIC.

william I. That a portion of an alleyway on West River Road and 49th Street, outside the right of way line needed for the widening of West River Road, described in Exhibit A attached hereto and made > past hereon, be and the same horaby is vacated.

SETTION $2\sim$ That the lends within the limits of said portion of an wileyer, on West River Rost and 49th Street, outside the right of way line needed too the widening of Wost River Road, as they are now estable lished, shall cenain octaithst and and the passage of this Ordinance, subject to the rights of utilities now maintaining said lands, to combine to maintain such structures, fixtures and appurtenances, and to enter upon said lands whenever reasonably necessary to do so for the purpose of inspecting, altering, replacing, repairing, patrolling and maintaining such structures, flitteres and appurtenances.

SECTION 3- That the portion of an alleyway on West River Rank and 49th Street, outside the right of way line needed for the widening of West River Road, at herein vacated, shall revert to the owners of the adjacent property.

SCOTION 4: That it is found and determined that all formal Actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees, that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revisco Code.

SECTION 5: That this Ordinance is and is hereby declared to he are emergency measure, the emergency being the immediate necessity to provide for the public health, pease and welfere of the people of the City of Elyria by providing for the variation of an alleyway on West Raver Road and 49th Street, outside the right of way line needed for the wide alog of Wert River Road, wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval.
