AN ORDINANCE VACATING A PORTION OF WARREN STREET, AND
DECLARING AN EMERGENCY

WHEREAS, this Council is satisfied that there is good cause shown for the vacation of a portion of Warren Street, and that it will not be detrimental to the general interest and ought to be made;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ELYRIA,
STATE OF OHIO:

SECTION 1: That a portion of Warren Street be and the same hereby is vacated as follows:

The street right of way located between Sublots 41 and 42, and located between the Southerly right of way of Baldwin Avenue and the Northerly property line of the Elyria City Board of Education, as recorded in Lorain County Record of Plats, Volume 7, Page 31.


SECTION 2: That the lands within the limits of said street right of way, as they are now established, shall remain notwithstanding the passage of this Ordinance, subject to the rights of utilities now maintaining said lands, to continue to maintain such structures, fixtures and appurtenances, and to enter upon said lands whenever reasonably necessary to do so for the purpose of inspecting, altering, replacing, repairing, patrolling and maintaining such structures, fixtures and appurtenances.

SECTION 3: That the street as herein vacated shall revert to the owners of the adjacent property, one half to the owner of Sublot 41, and one half to the owner of Sublot 42.

SECTION 4: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 5: That this Ordinance is and is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public health, peace and welfare of the people of the City of Elyria by providing for the vacation of a portion of Warren Street; wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval.


