



Ordinance No. 79-31

Passed June 18 1979

AN ORDINANCE ENACTED PURSUANT TO SECTION 723.04 OHIO REVISED CODE CHANGING THE NAME OF CASSELL PARKWAY TO ROLLING MEADOW DRIVE AS THE SAME EXTENDS GENERALLY NORTHEASTERLY FROM WEST RIVER ROAD TO ITS CULDESAC TERMINUS, ALL AS HAS BEEN FAVORABLY RECOMMENDED BY THE VERMILION CITY PLANNING COMMISSION AND AS REQUESTED BY ALL PROPERTY OWNERS ABUTTING THEREUPON AND DECLARING AN EMERGENCY.

WHEREAS, this City has received requests from all property owners abutting upon that public thoroughfare known as Cassell Parkway to change the name thereof to Rolling Meadow Drive; and

WHEREAS, the Planning Commission at its regular meeting of April 26, 1979, did favorably recommend hereupon; and

WHEREAS, notice of a pendency of this action has been made and a public hearing held hereupon.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Vermilion, Counties of Erie and Lorain, State of Ohio:

SECTION 1: That pursuant to the authority granted to this Council by Section 723.04 Ohio Revised Code and the Charter of the City of Vermilion, and upon requests of the abutting property owners, and after favorable recommendation hereupon by Vermilion City Planning Commission at its regular meeting of April 26, 1979, the name of that public street located within the City of Vermilion known as Cassell Parkway be and the same is hereby changed and amended to henceforth be known as Rolling Meadow Drive as the same extends in a generally northeasterly distance from West River Road to its culdesac terminus.

SECTION 2: That the Clerk of this Council shall forward a certified copy hereof to the County Auditor, the County Engineer, and the County Recorder of Erie County Ohio, requesting that they make proper amendatory notation upon their official records.

SECTION 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and welfare of the City, for the reason that no objection has been made to the within re-naming and it is fitting and appropriate to accommodate the citizenry of this City at as early a time as is possible; and provided it receives the majority vote of two-thirds or more of those elected or appointed to City Council, it shall go into full force and effect from and immediately after its passage and its approval by the Mayor; otherwise it shall take effect at the earliest period allowed by law.
