In the matter of authorizing the change )  
of name for Kipton Nickle Plate Road in ) July 3, 1979  
Camden Township to be known as Plate Road. )

WHEREAS, the Board of Commissioners provided for a public hearing on June 19, 1979 for consideration on the changing of name for Kipton Nickle Plate Road to Plate Road; and

WHEREAS, interested property owners received a notice two weeks in advance for this request; and

WHEREAS, the township trustees were not present and the Board delayed action on the matter pending notification to the Trustees;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that having been satisfied due and sufficient notice was given all parties involved, we do and hereby determine to change the name of Kipton Nickle Plate Road between State Route 20 and Baumhart Road, bw now known as "PLATE ROAD" IN THE TOWNSHIP OF CAMDEN.

FURTHER BE IT RESOLVED that the Lorain County Engineer and the Township Trustees be advised of this action for the proper marking of road records.

The foregoing resolution was introduced upon a motion by Commissioner Fred M. Ritenauer, seconded by Commissioner Jeresmo J. Keron and the vote taken thereon resulted as follows: Fred M. Ritenauer, "aye"; Jeresmo J. Keron, "aye"; Alan J. Zaleski, "aye".
