for vacating an alley in Sheffield Township.) August 28, 1979

WHEREAS, after due and sufficient legal advertising this is the day fixed for the public hearing on determining to vacate an alley in Sheffield Township; and after hearing and due consideration thereof, a motion was duly made and seconded;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby determine to vacate an alley in Sheffield Township, Ridge View Heights Allotment as recorded in Volume 8 on page 21 of the Lo. Co. Plat Records, which description reads as follows:

Said alley is located between Grant Street and Lincoln Street; bordered on the West by Clinton Avenue and on the East by Oakwood Avenue. The length of said alley being 798.9 feet and 15 feet in width. Alley is situated in Ridge View Heights Allotment, Sheffield Township.


FURTHER BE IT RESOLVED by the Board of Commissioners that permanent easements to public utilities within this vacated alley will be maintained pursuant to Section 5553.043.

BE IT FURTHER RESOLVED that the Clerk is directed to notify the Engineer, Tax Map, Lorain County Auditor and Lorain County Recorder of the granted petition on alley vacation.
