RESOLUTION NO. 80-7

In the matter of dedicating Overlook Drive)
for public use, located in Carlisle Township.) January 8, 1980

WHEREAS, the Carlisle Township Trustees by letter dated November 14, 1979 requested dedication of Overlook Drive in their Township as remains undedicated;

WHEREAS, the Lorain County Engineer advised that the blacktop portion of Overlook Drive is 1,245 feet in total length, of which 580 feet is dedicated;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby dedicate 665 feet, the remaining portion of Overlook Drive in Carlisle Township to public use.

FURTHER BE IT RESOLVED that we do and hereby direct that copies of this resolution be forwarded to the Lorain County Engineer, Tax Map and the Carlisle Township Trustees for record purposes.
