ORDINANCE NO. 82- 206

AN ORDINANCE NAMING THE ALLEY BETWEEN WOODBURY AND EDGEWOOD STREETS " ARNIE'S LAME ", AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ELYRIA, STATE OF CHIO:

SECTION 1: That the alley between Woodbury and Edgewood Streets be and me same hereby is named "Arnie's Lane".

SECTION 2: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance is and is hereby declared to be an emergency measure, the emergency being the immediate necessity to provide for the public health, peace and welfare of the people of the City of Elyria by providing for the naming of the alley between Woodbury and Edgewood Streets "Arni: s Lane ", wherefore, this Ordinance shall be in full force and effect from and immediately after its passage and approval.
