

ORDINANCE NO. 8390

AN ORDINANCE AMENDING ORDINANCE NO. 845 WHICH RE-ESTABLISHED THE DOCK OR  
WATER LINES OF THE BLACK RIVER BETWEEN  
THE LIMA AVENUE BRIDGE AND POINTS OPPO-  
SITE THE FOOT OF THE ISLAND IN WENFIELD  
TOWNSHIP, FROM POINT NO. 112-A TO POINT  
NO. 126 AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN,

STATE OF OHIO:

SECTION 1: That Ordinance No. 845 passed and approved on the 1st day of August, 1904, and amended by Ordinance Nos. 4513, 5269 and 8358, designating the location of dock lines and points shall be further amended by relocating the dock lines as follows:

"Situated in Original Lot 3, Black River Township, Tract One, now in the City of Lorain and more particularly described as follows:

Beginning at dockline point No. 112-A which point is located in the west line of property now or formerly owned by the Baltimore and Ohio Railroad Company and the eastline of property now or formerly owned by the New York, Chicago, and St. Louis Railroad Company, whose coordinate (related to United States Government Coordinate system) is N 4644.67 and E 6904.74; thence N 36° 18' 12" E. a distance of 197.57 feet to point No. 114-A whose coordinate is N 4729.03 and E 6901.41; thence S 66° 43' 34" E a distance of 339.46 feet to a point No. 115-A whose coordinate is N 4409.14 and E 7734.96; thence S 29° 43' 06" E. a distance of 403.1 passing through point 116-B, to point No. 118-B whose coordinate is N 3996.42 and E 7933.75; thence S 4° 02' 03" E a distance of 102.53 feet to point No. 118-C whose coordinate is N 3894.66 and E 7946.37; thence S 0° 16' 33" E a distance of 250 feet to point No. 118-D whose coordinate is N 3816.03 and E 7946.77; thence S 26° 15' 16" W a distance of 167.8 feet to point No. 120-A whose coordinate is N 3193.64 and E 7734.59; thence S 22° 32' 27" W a distance of 222.46 feet to point No. 122 whose coordinate is N 2391.17 and E 7639.31; thence S 11° 48' 37" W a distance of 416.27 feet to point No. 124 whose coordinate is N 3503.71 and E 7601.11; thence S 19° 48' 49" W a distance of 176.55 feet to point No. 124-A whose coordinate is N 3616.61 and E 7613.96; thence S 33° 41' 12" W a distance of 111.61 feet to point No. 126-A whose coordinate is N 2523.36 and E 7676.10; thence S 65° 09' 32" W a distance of 266.74 feet to point No. 126 whose coordinate is N 2211.92 and E 7919.80."

SECTION 2: That the map of the dock lines as filed in the office of the City Collector (X-9) be corrected to indicate the dock line relocation as designated in this Ordinance.

SECTION 3: That this Ordinance is hereby declared to be an emergency ordinance, the nature of the emergency being the immediate necessity for the correcting of Black River Dock Line within the City of Lorain, Ohio, to permit the Federal Government to engage in their dredging program and for the improvement of the property of the riparian owner adjoining the said dock line, all for the welfare, and convenience of the inhabitants of the City of Lorain, provided it receives the affirmative vote of two thirds of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
