

ORDINANCE NO. 84-90

AN ORDINANCE ACCEPTING THE PLAT OF OAK POINT PROFESSIONAL PARK; TO THE CITY OF LORAIN, OHIO.

WHEREAS, the Lorain City Planning Commission approved the plat of Oak Point Professional Park at their regular meeting held on 28 June, 1989; and

WHEREAS, Lorain City Council concurred with the Lorain City Planning Commission approval of Oak Point Professional Park at a Council meeting held on 5 July, 1989.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

Section 1. That the Plat of Oak Point Professional Park (Lots 1 through 10) in the City of Lorain be and the same is hereby approved.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and of any of its Committees that resulted in such formal action, were in meetings open to the public and in compliance with all legal requirements, including Section 121.22, Ohio Revised Code.

Section 3. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.


