AN ORDINANCE DEDICATING THE WESTERLY EXTENSION OF TELEGRAPH LANE AS A DULY ACCEPTED PUBLIC THOROUGHFARE OF THE CITY OF VERMILION, OHIO AS SHOWN IN THE PLAT OF EDISON ESTATES SUBDIVISION NUMBER ONE; WALVING THE POSTING OF MAINTENANCE BOND AS REQUIRED BY SECTION 1113.10 CODIFIED ORDINANCES OF VERMILION AND DECLARING AN EMERGENCY.

WHEREAS, two City Engineers have recommended the approval and acceptance of the westerly extension of Telegraph Lane to become a duly dedicated public thoroughfare of the City of Vermillon, Ohio,

WHEREAS, the construction of such street was completed in 1983 and acceptance thereof delayed due to transition in City engineers, and,

WHEREAS, said street has remained in such approved and acceptable condition beyond that period of time which a maintenance bond would have covered and therefore it is not equitable to require additional maintenance period,

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Vermilion, Counties of Erie and Lorain, State of Ohio:

SECTION 1: That the westerly extension of Telegraph Lane in the City of Vermilion, Ohio, being shown on the plat of Edison Village Estates Subdivision Number One and as more specifically set forth herein, be and the same is hereby duly accepted by this City Council and is hereby officially dedicated as a public thoroughfare of the City of Vermillon. Said improved street being more fully described as follows:

Situated in the City of Vermilion, County of Lorain and State of Ohio, and being known as part of Original Brownhelm Township Lot No. 1, and more definitely described as follows:

Beginning at the Southwesterly corner of Sublot No. 2 in Edison Village Estates Subdivision No. 1, as recorded in Volume 35, Pages 72 and 73 of Lorain County Plat Records;

Thence South 0° 14' 49" West in the Southerly extension of the Westerly line of Sublot No. 2, a distance of 50.00 feet to a point;

Thence South 89° 20' 11" East, a distance of 80.00 feet to the Northwesterly corner of of Sublot No. 1 in Edison Village Estates Subdivision No. 1;

Thence North 0° 14′ 49" East in the Northerly extension of the Westerly line of Sublot No. 1, a distance of 50.00 feet to a point in the Southerly line of Sublot No. 2;

Thence North 89° 20′ 11" West in the Southerly line of Sublot No. 2, a distance of 80.00 feet to the place of beginning, enclosing a parcel containing 0.092 acres of land, but subject to all legal highways.

SECTION 2 That the Mayor and the City Engineer be and they hereby are authorized to cause the Lorain County Title Company to record a deed therefore conveying such street unto the City of Vermillon.

SECTION 3: That Section 1311.10 C.O.V. pertaining to the posting of a five percent maintenance guarantee be and the same is hereby waived for the reason that the normal maintenance period has long since expired and pursuant to the recommendation of the present City Engineer, said street has always remained in an acceptable and approved condition.

SECTION 4: That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the City of Vermilion and the inhabitants thereof for the reason that it is fair and equitable for the City of Vermilion to take jurisdiction over a public thoroughfare which has met construction requirements since 1983; and provided it receives the affirmed majority vote of two-thirds or more of those members elected or appointed to City Council, it shall take effect and go into full force immediately after its passage and its approval by the Mayor; otherwise it shall take effect at the earliest period allowed by law.
