> "We have reviewed the dedication plot of Hidden Valley Drive Extension (Extension) and recommended approval and accepted by the Board.

The Developer, First Federal Savings & Loan Association of Lorain, has completed the improvements to the roodway by constructing a concrete pavement with curbs and storm sewers, in accordance with the as-built plons submitted by K-S Associates, Consulting Engineers.

Hidden Valley Drive (Extension) with a county road number 1450 designation, from the centerline of Middle Ridge Road northerly a distance of 585.76 feet (0.11) miles to a point on the southerly line of Hidden Valley Drive Subdivision No. 4, and that said Hidden Valley extension is hereby dedicated to public use and is to be maintained by the Township of Amherst.

FURTHER BE IT RESOLVED that the maintenance guarantee agreement executed the 23rd doy of October, 1987 by the First Federal Savings & Loan Association is hereby accepted and which is effective one (1) year from the date of the executed Agreement.
