WHEREAS, the Lorain County Engineer by letter dated November 2, 1987 recommended the acceptance of the improvements of Flint Ridge Subdivision #2 in Eaton Township recorded in Plat Volume 36 page 50 and 51, and reapportionment plans recorded in Plat Volume 38 page 10 and 11, Lorain County Record of Plats as follows:

Flint Ridge Drive, with a County Road Number 219 designation from the west line of the subdivision easterly to a cul-de-sac, 3,007.57 feet or 0.57 miles in length.

Arrowhead Drive with a County Road Number 220 designation from Flint Ridge northerly, easterly and southerly to Flint Ridge Drive 2,914.16 feet or 0.55 miles in length. and

WHEREAS, the Board of Commissioners by Resolution No. 87-856 accepted Maintenance Guarantee Agreement submitted by the Dale Yost Construction Co.

NO, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby accept the improvements of Flint Ridge Subdivision #2 in Eaton Township, and that Flint Ridge Drive and Arrowhead Drive described as follows be hereby dedicated to public use:

Flint Ridge Drive - with a County Road Number 219 designation, from the west line of the subdivision easterly to a cul-de-sac, 3,007.57 feet or 0.57 miles in length.

Arrowhead Drive - with a County Road Number 220 designation from Flint Ridge northerly, easterly and southerly to Flint Ridge Drive 2,914.16 feet or 0.55 miles in length.

FURTHER BE IT RESOLVED by the Board of Commissioners that Flint Ridge Drive and Arrowhead Drive be accepted on behalf of the Eaton Township Trustees to become part of the Township Road system to be maintained by the Township.

The foregoing resolution was introduced upon a motion by Commissioner Herbert J. Jacoby, seconded by Commissioner George I. Koury, Jr., and the vote token thereon resulted as follows: Herbert J. Jacoby, "aye"; George I. Koury, Jr., "aye"; Leonard P. Reichlin, "aye".
