AN ORDINANCE ACCEPTING FOR DEDICATION THE FINAL SUBDIVISION PLAT FOR BEDFORD ESTATES NO. 2, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 87-230

WHEREAS, there has been submitted to the Council the Final Subdivision Plat for Bedford Estates No. 2; and
