We have reviewed the description and it follows the map enclosed.

The length proposed to be vacated is 129.03 feet (centerline) by sixty feet wide.

This office does not recommend vacation for the following reasons:

A 6" waterline has been installed within the area proposed to be vacated.

The frontage would be reduced from 129 to 30 feet. A potential four (4) building lots would be reduced to two (2) provided the township would allow building on a lot. with 30 feet of frontage.

The Elyria Township Trustees may have additional comments regarding drainage and safety hazards as to the public health and welfare.

Beginning at the Southeast corner of Sublot No. 228 of said Subdivision, said corner being located on the Northerly line of Elmwood Street;

Thence due West along the Southerly lines of Sublot Nos. 228 thru 225 inclusive, of said Subdivision, a distance of 128.27 feet to the Southwest corner of Sublot No. 225;

Thence South 1° 32' 30'' West along the Westerly line of said Subdivision, adistance of 60.00 feet to the Northwest corner of Sublot No. 327 of said Subdivision;
