WHEREAS, on the date of May 5, 1988 a Petition for annexing property to the City of Oberlin contiguous to and owned by the City located in Pittsfield Township known as Lot #14, was received and journalized on pages 260-A and 260-B; and

WHEREAS, the Board of Commissioners received an Ordinance #88-15 AC-CMS passed by City Council on date of April 4, 1988 requesting the annexing of the above described property to the City; and

WHEREAS, the Clerk of the Board presented to the Board of County Commissioners on date of May 10, 1988 that the Petition was filed with her and was now ready for action by the County Commissioners; and

WHEREAS, the Lorain County Auditor and Lorain County Engineer certified to the Board of Commissioners their findings that the property was correct in its description and that it was contiguous to and owned by the City of Oberlin.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Larain County, Ohio, that as provided by Section 709.16 of the Ohio Revised Code, we do and hereby authorize immediate onnexation of the following described property to the City of Oberlin, and that this action becomes effective May 26, 1988 by its order made upon the journal proceedings:

Thence Westerly in the nartherly right of way of U.S. Route 20, a distance of 100.05 feet to the principal place of beginning;

Enclosing a parcel containing about 3.40 acres, but subject ta all legal highways.

WHEREFORE, the City of Oberlin respectfully petitions that said territory be annexed to the City of Oberlin.



ORDINANCE NO. 88-15 AC CMS

AN ORDINANCE AUTHORIZING THE ANNEXATION OF CERTAIN MUNICIPALLY OWNED REAL PROPERTY TO THE CITY AND AUTHORIZING AND DIRECTING THE CITY SOLICITOR TO PROSECUTE THE PROCEEDINGS NECESSARY TO EFFECTUATE SUCH ANNEXATION AND DECLARING AN EMERGENCY

WHEREAS, the City of Oberlin is the fee-simple owner of certain real property located within Pittsfield Township and contiguous to the City of Oberlin Municipal Corporation line; and,

WHEREAS, it is in the best interests of the City of Oberlin and its citizens to annex such real property to the City;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the annexation of the real property located in Pittsfield Township, which is contiguous to the Municipal Corporation limit of the City of Oberlin, to the City of Oberlin, Ohio, be and the same is hereby authorized, said property being described in Exhibit A attached hereto and further described as Lorain County Auditor's Permanent Parcel Number 14-00-014-000-003.

SECTION 2. That the City Solicitor is hereby authorized and directed to prosecute all proceedings necessary to effectuate such annexation, to be charged as extraordinary services.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, to-wit:

"to begin the annexation process at the earliest possible date" | do hereby certify that the above and foregoing
