ORDINANCE NO. 9-06

**AN ORDINANCE VACATING THE ALLEY WEST OF BROADWAY AVE.  
FROM THE SOUTHLINE OF WEST 27<sup>TH</sup> STREET SOUTHERLY TO THE  
NORTHLINE OF WEST 28<sup>TH</sup> STREET.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
LORAIN, STATE OF OHIO:**

- SECTION I. This council finds that a petition signed by the owners of all of the property abutting upon the alley west of Broadway Ave. from the Southline of West 27<sup>th</sup> Street southerly to the Northline of West 28<sup>th</sup> Street has been presented to this Council, praying that said alley between the points be vacated (see attached).
- SECTION II. Council further finds that there is good cause for such vacation of said alley as prayed for, that such vacation of the alley will not be detrimental to the general interests and ought to be made.
- SECTION III. The alley west of Broadway Ave. from the Southline of West 27<sup>th</sup> Street southerly to the Northline of West 28<sup>th</sup> Street is hereby vacated.
- SECTION IV. The City Engineer is hereby instructed to prepare a vacation plat or plats of said vacated alley and the Clerk of Council is instructed to endorse upon such plat or plats the action of this Council in vacating such portion of the alley and to cause said plat or plats to be recorded in the Office of the Recorder of Lorain County, Ohio.
- SECTION V. The Clerk of Council is directed to notify the Auditor of Lorain County of the vacation by sending him a copy of this ordinance.
- SECTION VI. All formal actions of Council relating to the adoption of this ordinance, and all deliberations of Council and any of its committees leading to such action, were in meetings open to the public as required by law.
- SECTION VII. This ordinance shall take effect at the earliest time allowed by law.
