WHEREAS, a Petition was received from interested property owners in the West View Park Subdivision, Original Lot Number 20, Columbia Township, Lorain County, Ohio, to vacate a section of road right-of-way, known as Lafayette Drive, east of Aldridge Avenue; and

WHEREAS, the Lorain County Engineer by letter dated December 1, 1994 submitted the following report:

"This office has reviewed the petition submitted by the Columbia Township Trustees for the vacation of a section of road right-of-way known as Lafayette Drive. The description of the right-of-way on the petition agrees with the map presented with the petition.

Lafayette Drive is part of the West View Park Subdivision as recorded in Volume 13, page 1, of the Lorain County Record of Plats. This section of Lafayette Drive exists on "paper" only. There is no pavement in place that is maintained by the township.

To the Honorable Board of Lorain County Commissioners

We, the undersigned residents of Columbia Township, Original Lot 20, Lorain County, Ohio hereby petition you to vacate Lafayette Drive, east of Aldridge Avenue.

It is a "paper" road, shown on the plot map but not established or maintained as a township road.


This viewing and hearing has been provided pursuant to Ohio Revised Code Sections 5553.04 and 5553.05.
