THIS MATTER came on for trial on the 8th day of January, 1986, the Plaintiff being present through its legal counsel and the substituted Defendant, H. R. Kopf, being present through his legal counsel, and no other parties or their legal counsel appearing on their behalf at such scheduled time.

It being represented to the Court that the owner of the property appropriated in this action has agreed with the Municipality of the City of Avon Lake, Lorain County, Ohio, upon the amount of compensation and damages due said owner by reason of said appropriation and has agreed to accept the amount of Thirty-four Thousand and no/100 Dollars (\$34,000.00) in full payment thereof, and does hereby release all claims for further compensation or damages resulting from the widening and improving of Avon-Belden Road or from the appropriation of said property, now, therefore,

In conformity with said agreement, it is hereby ordered, adjudged and decreed that the said Municipality of the City of Avon Lake, Lorain County, Ohio, shall deposit with the Clerk of this Court, a sum sufficient, to wit: One Thousand and Nine Hundred Sixty-five and no/100 Dollars (\$1,965.00), which when added to the original deposit herein of Thirty Two Thousand Thirty-five and no/100 Dollars (\$32,035.00) equals the total amount of the agreed settlement of Thirty-Four Thousand and no/100 Dollars (\$34,000.00), which shall be paid to the landowner hereinafter named, upon application to this Court, with no interest.
