WHEREAS, notices were forwarded to Utility Companies, with columbia Gas and Ohio Edison responding they have no objection to this vacation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Lorain County, Ohio, that we do and hereby determine and authorize the vacation of the following described alley;

Beginning at the Southeasterly Corner of Sublot No. 432, as recorded in The Liberty Subdivision Plat Volume 9, Page 26 of the Lorain County Records of Plats, said Point being the Frincipal Point of Beginning of the lands herein described;

Thence Northerly a distance of about 119.50 feet to a Point, said Point also being the Northeasterly Corner of Sublot No. 429 of the Plat aforementioned;

Thence Easterly along the Southerly right of way line of Wilson Street a distance of 16.00 feet to a Point, said Point also being the Northwesterly corner of Sublot No. 352 of the Plat aforementioned;

Thence Southerly a distance of about 119.50 feet to a Point, said Point also being the Southwesterly Corner of Sublot No. 349 of the Plat aforementioned;

Thence Westerly along the northerly right of way line of Vincent Avenue (A.K.A. School Ave.) a distance of 16 feet to the Principal Point of Egginning.
