WHEREAS, the Lorain County Engineer by letter dated May 9, 1995 submitted the following review and recommendation:

"This office has reviewed the description of Kay Drive Extension, T-1361, and find it correctly follows the proposed extension, as indicated on County tax maps.

The extension includes about a 20' radius cul-desac, consisting of stone base and chip and seal. The cul-de-sac ends about 40 feet + west of the east property line and there is a large ditch between the cul-de-sac and the property line.

Since the deed for this extension of 105.53 feet has been approved by the Planning Commission and has been recorded in the County Recorders O.R. Volume 987, Page 856, and the Amherst Township Trustees are willing to accept this road in its present condition, we see no reason the Board can not accept this as road right-of-way for public use, in the name of Amherst Township.
