ORDINANCE ACCEPTING APPLICATION FOR ANNEXATION.
(Original Lot No. 1 in Elyria Township and Part of
Original Lot No. 113 in Sheffield Township).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, COUNTY OF LORAIN, STATE OF OHIO:

Section 1. That the application of John DiFrancesco for the annexation of the following described territory in the County of Lorain and adjacent to the City of Lorain, Ohito wit:

Situated in the Township of Elyria, County of Lorain, and State of Ohio. Being known as part of Original Lot No. 1 of the Newberry Tract of Elyria Township. Also; situated in the Township of Sheffield, County of Lorain, and State of Ohio. Being known as part of Original Lot No. 113 of Sheffield Township; and more definitely described as follows:

Beginning at the intersection of the center line of North Ridge Road (Cooper-Foste Park Road) also known as Ohio State Route 254, and the line between Elyria Township and Amherst Township.

Thence Northerly in the line between Sheffield Township and Black River Township distance of 40.00 feet the North sideline of North Ridge Road.

Thence South 88⁰ 33' 58" East in the North sideline of North Ridge Road, to a point where the Southeast sideline of Middle Ridge Road, extending Northeasterly intersects the North sideline of North Ridge Road.

Thence Southwesterly, in the Northeasterly extension of the Southeast sideline of Middle Ridge Road, and the Southeast sideline of Middle Ridge Road, to a point where the South Line of Sublot No. 10 of the Herrick Allotment, as recorded in Vol 15, Page 57 of Lorain County Record of Plats, extended Southeasterly intersects the Southeast sideline of Middle Ridge Road.

Thence Northwesterly, in the Southwest line of Sublot No. 10, and the Southwest line extended Southeasterly, to the WK Southeastern line of Sublot No. 12.

Thence Northeasterly in the Northwest line of Sublots Nos. 10 and 9 to the South of Sublot No. 6 in the Herrick Allotment.

Thence Westerly, in the South line of Sublots Nos. 6, 5, 4, 3, 2 and 1, of the Herrick Allotment, to the line between Elyria Township and Amherst Township.

Thence Northerly, in the line between Elyria Township and Amherst Township, a distance of 225.04 feet to the place of beginning, enclosing a parcel of land containing about 7.36 acres of which .92 acres of land are in Original Lot No. 11 in Sheffield Township; and 6.44 acres are in Original Lot No. 1 of the Newberry T in Elyria Township, be the same more or less, but subject to all legal highways.
