AN ORDINANCE TO CORRECT THE NAME DESIGNATION OF "BRENNAN" DRIVE WITHIN THE CITY OF AMHERST, OHIO.

WHEREAS, that certain street located in the City of Amherst, designated on the original plat filed in the office of the Lorain County Recorder as "Brennen Drive" has become commonly known as "Brennan Drive" and such designation appears on the street signs and zoning map of City of Amherst; and

WHEREAS, the Council of the City of Amherst upon recommendation from the Building Department has determined the necessity of effecting a name change so that such street hereafter will be known exclusively as "Brennan Drive."

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Amherst, County of Lorain, State of Ohio:

SECTION 1. That that certain street located in the City of Amherst, County of Lorain, State of Ohio as designated on the original plat filed in the office of the Lorain County Recorder at Plat Volume 20, Page 12, as "Brennen" Drive, be, and hereby is, changed to "Brennan Drive" for all purposes. Such street is more specifically indicated on the map attached hereto as Exhibit "A", and incorporated herein for all purposes. The Clerk of the Council of the City of Amherst is hereby authorized and directed to forward a certified copy of this ordinance, together with Exhibit "A" attached thereto, to the Lorain County Tax Map office and office of the Lorain County Recorder to be recorded in the records of Lorain County.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, and in compliance with all legal requirements, including Section 121.22 Ohio Revised Code.

WHEREFORE, this ordinance shall be in full force and effect at the earliest time permitted by law.

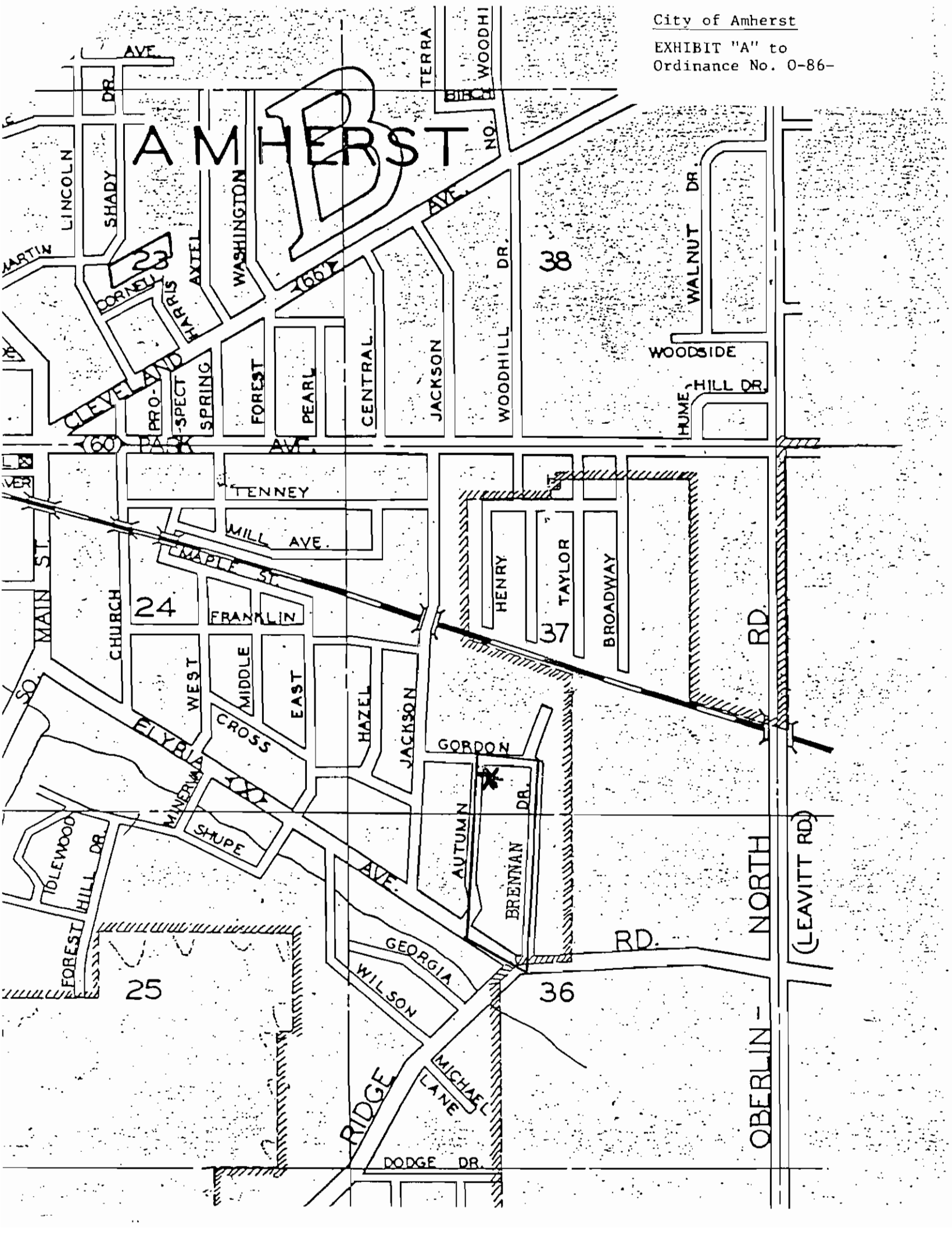
