ORDINANCE NO. 0-93- 53

AN ORDINANCE TO CHANGE THE NAME DESIGNATION OF ICHABOD LANE TO FALLEN OAK LANE WITHIN THE CITY OF AMHERST, AND DECLARING AN EMERGENCY.

WHEREAS, the Streets Committee of the Council of the City of Amherst at its regular meeting held on June 21, 1993 determined the necessity of changing the name of Ichabod Lane to Fallen Oaks Lane.

NOW, THEREFORE, BE IT ORDAINED, by the City of Amherst, County of Lorain, State of Ohio:

SECTION 1. That the name of that portion of roadway designated as Ichabod Lane on the existing tax maps of Lorain County, be, and it hereby is, changed to Fallen Oak Lane.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of Amherst, Ohio. The emergency being the immediate necessity of changing the name designation of Ichabod Lane to Fallen Oaks Lane within the City of Amherst.

WHEREFORE, this ordinance shall be in full force and effect immediately upon its passage and approval.
