ORDINANCE NO. 0-96-79

AN ORDINANCE VACATING A PORTION OF GOLDEN RUSSET BOULEVARD.

WHEREAS, the Building and Lands Committee of the Council of the City of Amherst, at its regular meeting held September 16, 1996, has determined to vacate a portion of Golden Russet Boulevard north of Jonathan Street.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Amherst, County of Lorain, and State of Ohio:

- SECTION 1. The Council of the City of Amherst finds that a petition signed by the owner of all the property abutting the northerly portion of Golden Russet Boulevard north of Jonathan Street has been presented to this Council praying that said street between the points named be vacated.
- SECTION 2. Council further finds that there is good cause for such vacation of said street as prayed for. That such vacation of street will not be detrimental to the general interests and ought to be made.
- SECTION 3. Golden Russet Boulevard north of Jonathan Street be and the same hereby is vacated on the condition that the owner of all properties abutting thereupon shall convey to the City of Amherst easements for the construction, maintenance and operation of various public utilities publicly owned and otherwise, as the City Engineer deems appropriate.
- SECTION 4. The City Engineer is hereby instructed and directed to prepare vacation plats of said vacated street and the Clerk of Council is instructed to endorse upon such plat the action of this Council in vacating such portion of street and to cause said plat to be recorded in the office of the Recorder of Lorain County, Ohio.
- SECTION 5. The Clerk of Council is directed to notify the Auditor and Treasurer of Lorain County, Ohio, of the vacation by sending a copy of this ordinance.
- SECTION 6. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 Ohio Revised Code.
