RESOLUTION NO. R-86-26

A RESOLUTION TO ADOPT A MAJOR THOROUGHFARE AND COMPREHENSIVE PLAN FOR THE CITY OF AMHERST, OHIO AND TO REPEAL RESOLUTION 86-13.

WHEREAS, the Planning Commission of the City of Amherst, Ohio at a regular meeting held November 26, 1985 has recommended to the Council of the City of Amherst, Ohio that a Major Thoroughfare and Comprehensive Plan for the City of Amherst, Ohio be adopted in accordance with the plan as submitted by the Lorain County Regional Planning Commission; and

WHEREAS, the Council of the City of Amherst, Ohio, after appropriate action, has determined the necessity of adopting a Major Thoroughfare and Comprehensive Plan for the City of Amherst, Ohio in accordance with the plan submitted by the Lorain County Regional Planning Commission.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Amherst, County of Lorain, State of Ohio:

SECTION 1. The Major Thoroughfare and Comprehensive Plan as prepared by the Lorain County Regional Planning Commission on September 19, 1973 and revised November 24, 1976 and on file with the Lorain County Planning Commission and the Lorain County Regional Planning Commission report number 14 titled "Parks Recreation And Open Space, A Plan For Lorain County Ohio" on file with the Lorain County Planning Commission and dated January 28, 1971 be, and the same hereby is adopted by the City of Amherst, Ohio.

SECTION 2. That the Clerk of the Council of the City of Amherst, Ohio is directed to notify the Lorain County Regional Planning Commission of the adoption of the Major Thoroughfare Plan and Comprehensive Plan by forwarding a certified copy of this resolution instructing that the same be recorded in the office of the Lorain County Recorder.

SECTION 3. Resolution No. 86-13 is hereby repealed.

SECTION 4. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 Ohio Revised Code.

WHEREFORE, this resolution shall be in full force and effect at the earliest time permitted by law.
