WHEREAS, Ken Carney, Lorain County Engineer duly advertised for bids and the following bids were opened on March 25, 2021;

U.S. Bridge division of the Ohio Bridge Corp., Cambridge, Ohio \$256,440.00

And;

WHEREAS, this project includes the supply and delivery of a galvanized steel beam bridge superstructure and related materials to the site of the Smith Road Bridge No. 0403 in Penfield/Spencer Townships in Lorain and Medina Counties, Ohio. The delivered structure is 71' c/c bearing with a 28' roadway width.

WHEREAS, Engineer is recommending U.S. Bridge division of the Ohio Bridge Corp. They agree to commence work on or before July 15, 2021 and complete all work by September 1, 2021. They have proposed no substitutions and subcontractors for this project are Voigt & Schweitzer, LLC.

NOW, THEREFORE, BE IT RESOLVED by the Board of Lorain County Commissioners, that based upon the recommendation of Lorain County Engineer we hereby approve and enter into a contract with U.S. Bridge division of the Ohio Bridge Corp., Cambridge, Ohio, in the amount of \$256,440.00 for the Smith Road Bridge No. 0403 project in Lorain County.

FUTHER BE IT RESOLVED, we will issue a Notice to Proceed upon full execution of the contract authorizing work to begin on or around July 15, 2021 and the work will be completed on or before September 1, 2021.


BE IT FURTHER RESOLVED, we hereby authorize The Lorain County Administrator to notify The County Auditor to release retainage at the completion of the project.
