Please be advised that Ohio Edison Company received title to the properties depicted on its Maps 47-094 thru 47-093 in a conveyance from Toledo Edison Company by an instrument recorded in Volume 645, at Page 450 of the Lorain County Deed Records. The Company received title to the property depicted on Map 47-004 from Toledo Edison Company by an instrument recorded in Volume 645, Page 446.

The description for the property being conveyed is listed in Paragraph F of Page 7 of said instrument. Through a typographical error the County listed is Erie instead of Lorain. The original conveyance to the Lake Shore Electric Railway Company describes the same six acres in an instrument recorded in Volume 395, at Page 423.
