

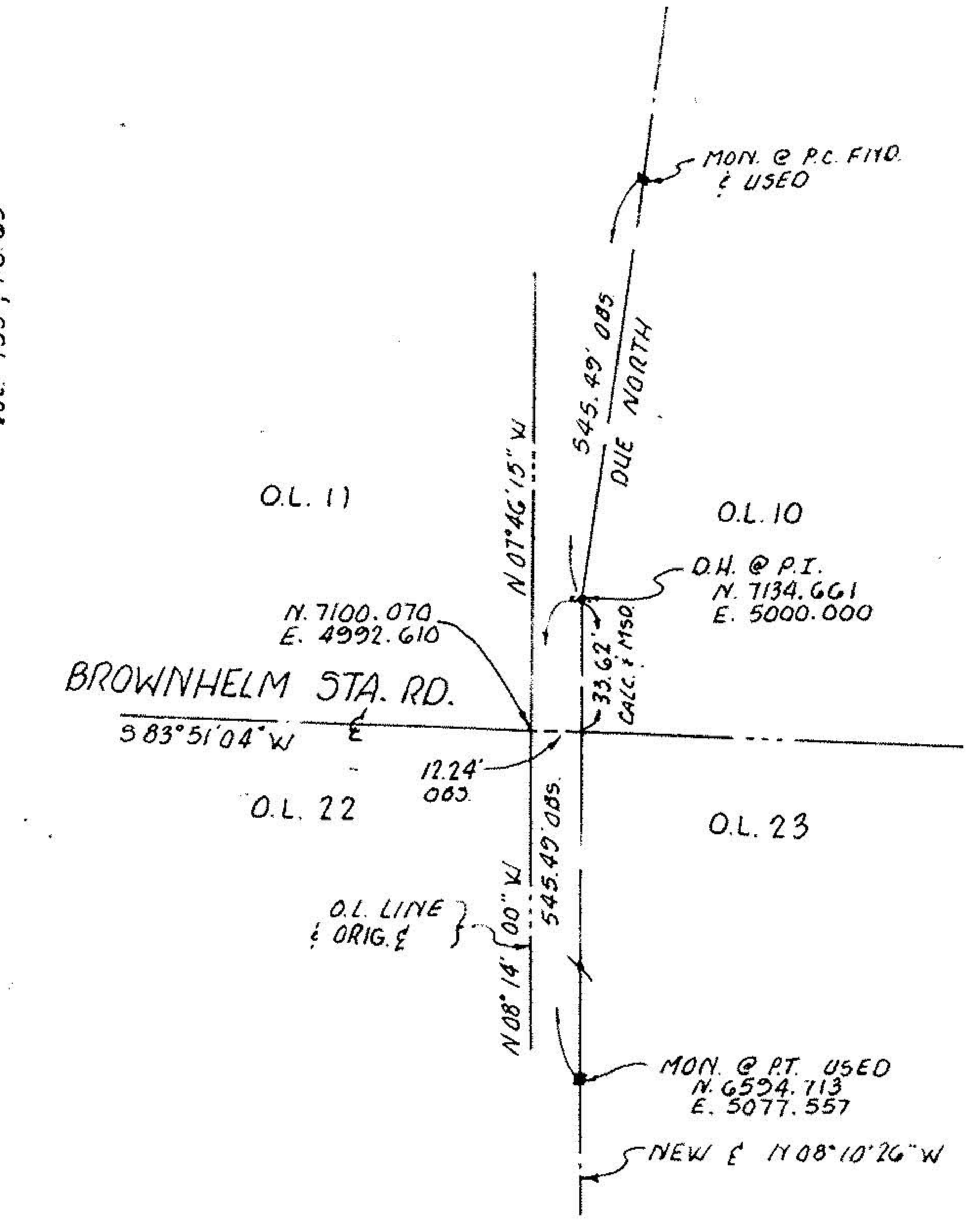
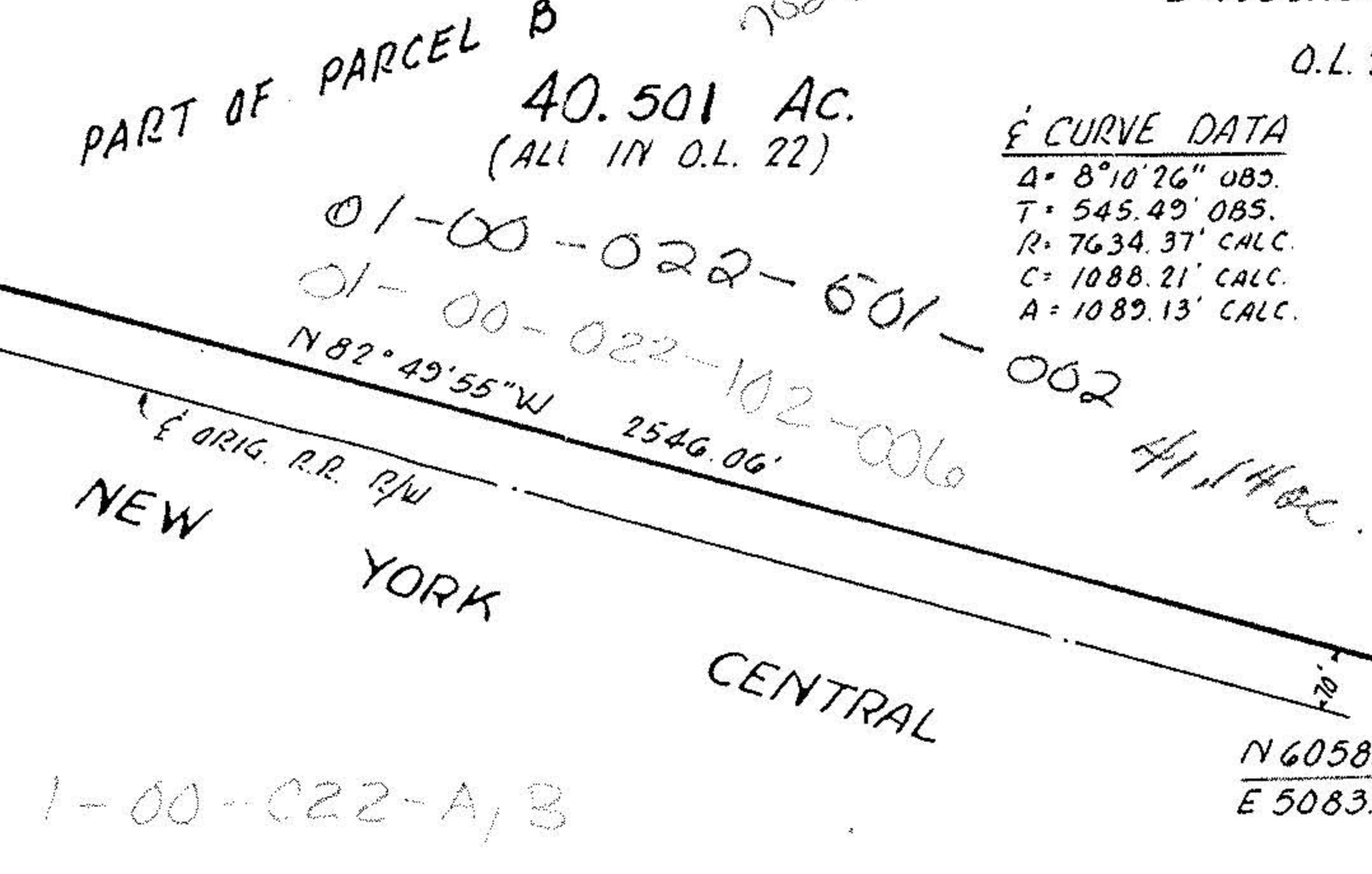
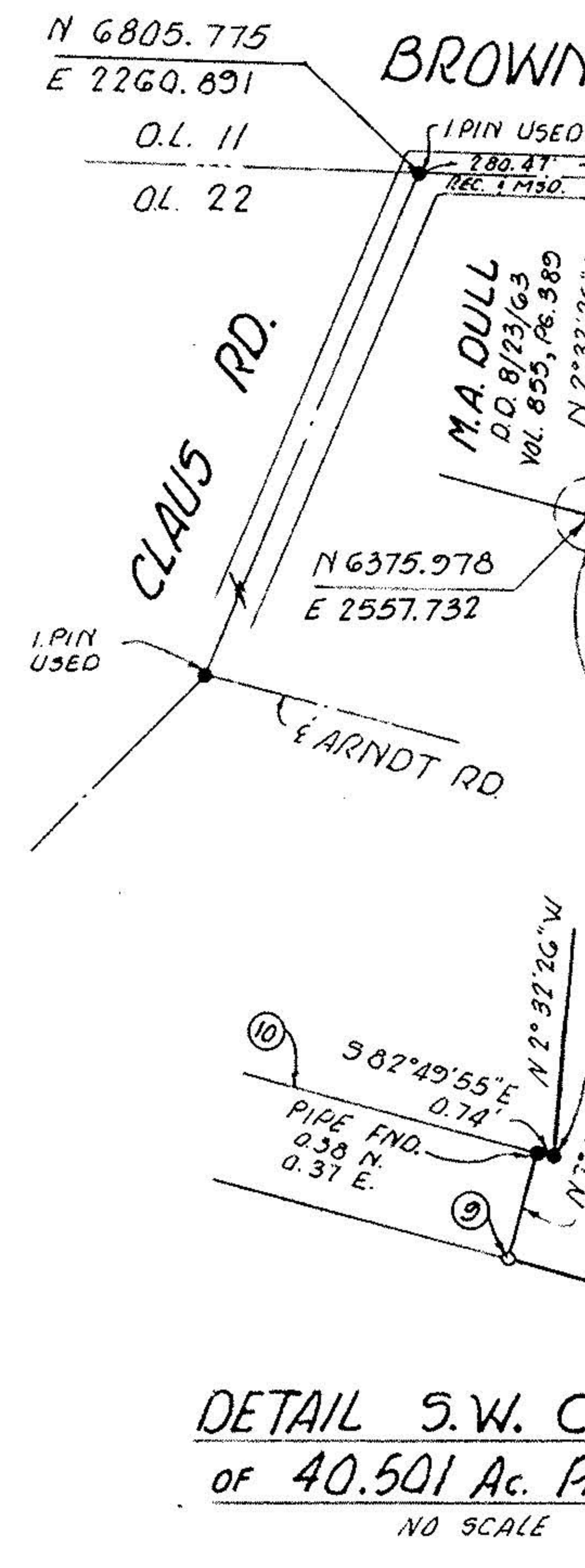
**MAP OF SURVEY FOR
