Situated in the Township of Brownhelm, County of Lorain, State of Ohio, and being known as parts of Original Lot Nos. 39 and 42 in said Brownhelm Township, and being further described as follows:

Beginning at the intersection of the Easterly line of said Original Lot No. 39 and the centerline of North Ridge Road (66 feet wide);


Thence, South 61 degrees 48'07" West a distance of 148.22 feet along the centerline of North Ridge Road, to the Principal Place of Beginning;

Thence, South 06 degrees 50'21" East a distance of 792.39 feet to an iron pin set on the Northerly line of land conveyed to Milad Abraham by deed recorded in Official Record Volume 620 page 877 of Lorain County Recorder's Records on August 14, 1996, said line passes through an iron pin set 35.43 feet Southerly from the centerline of North Ridge Road;

Thence, South 84 degrees 30'57" West a distance of 140.14 feet along the Northerly line of said land conveyed to Milad Abraham, to a 1 1/4" iron pipe found and used at the Southeasterly corner of land conveyed to Kenneth P. and Karen D. Kauk by deed recorded in Official Record Volume 789 Page 162 of Lorain County Recorder's Records on October 15, 1993;

Thence, North 06 degrees 48'26" West a distance of 734.45 feet along the Easterly line of said land conveyed to Kenneth P. and Karen D. Kauk to the Northeasterly corner thereof and being a point on the centerline of North Ridge Road, said line passes through an iron pin set 35.44 feet Southerly

Thence, North 61 degrees 48'07" East a distance of 150.00 feet along the centerline of North Ridge Road, to the Principal Place of Beginning, containing 2.4518 Acres of which 1.12 Acres lies in Original Lot No. 42 and 1.33 Acres lies in Original Lot No. 39 as surveyed by Thomas A. Simon, Registered Professional Surveyor No. S-7775 in January, 2001. Basis of bearings is the centerline of Caps "T. Simon, S-7775".

Situated in the Township of Brownhelm, County of Lorain, State of Ohio, and being known as parts of Original Lot Nos. 39 and 42 in said Brownhelm Township, and being further described as follows:

Beginning at the intersection of the Easterly line of said Original Lot No. 39 and the centerline of North Ridge Road (66 feet wide):

Thence, South 06 degrees 50'21" East a distance of 849.64 feet along the Easterly line of said Original Lot Nos. 39 and 42 to a 1 1/4" iron pipe found and used at the Northeasterly corner of land conveyed to Milad Abraham by deed recorded in Official Record Volume 620 page 877 of Lorain County Recorder's Records on August 14, 1996, said line passes through a 1/2" iron pin set in concrete found and used, 35.49 feet Southerly from the centerline of North Ridge Road;

Thence, South 84 degrees 30'57" West a distance of 138.08 feet along the Northerly line of said land conveyed to Milad Abraham to an iron pin set thereon;

Thence, North 06 degrees 50'21" West a distance of 792.39 feet to a point on the centerline of North Ridge Road, said line passes through an iron pin set 35.43 feet Southerly therefrom;

Thence, North 61 degrees 48'07" East a distance of 148.22 feet along the centerline of North Ridge Road, to the Place of Beginning containing 2.6018 Acres of which 1.06 Acres lies in Original Lot No. 42 and 1.54 Acres lies in Original Lot No. 39 as surveyed by Thomas A. Simon, Registered Professional Surveyor No. S-7775 in January, 2001. Basis of bearings is the centerline of North Ridge Road (South 61 degrees 48'07" West). Iron pins set are 5/8" diameter, 30" long with plastic caps "T. Simon, S-7775".
