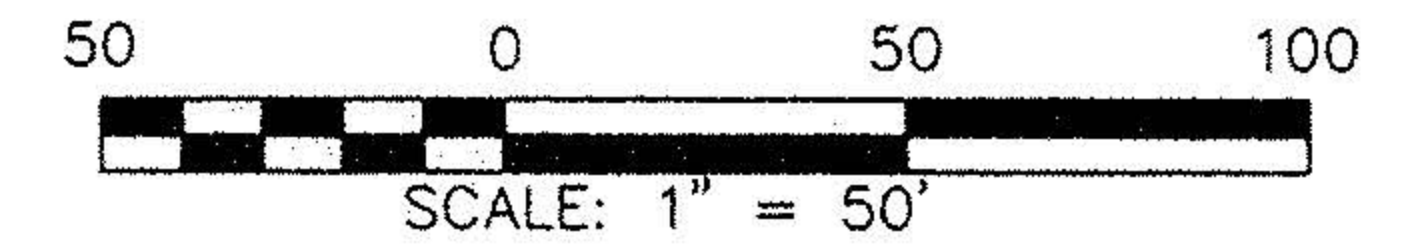

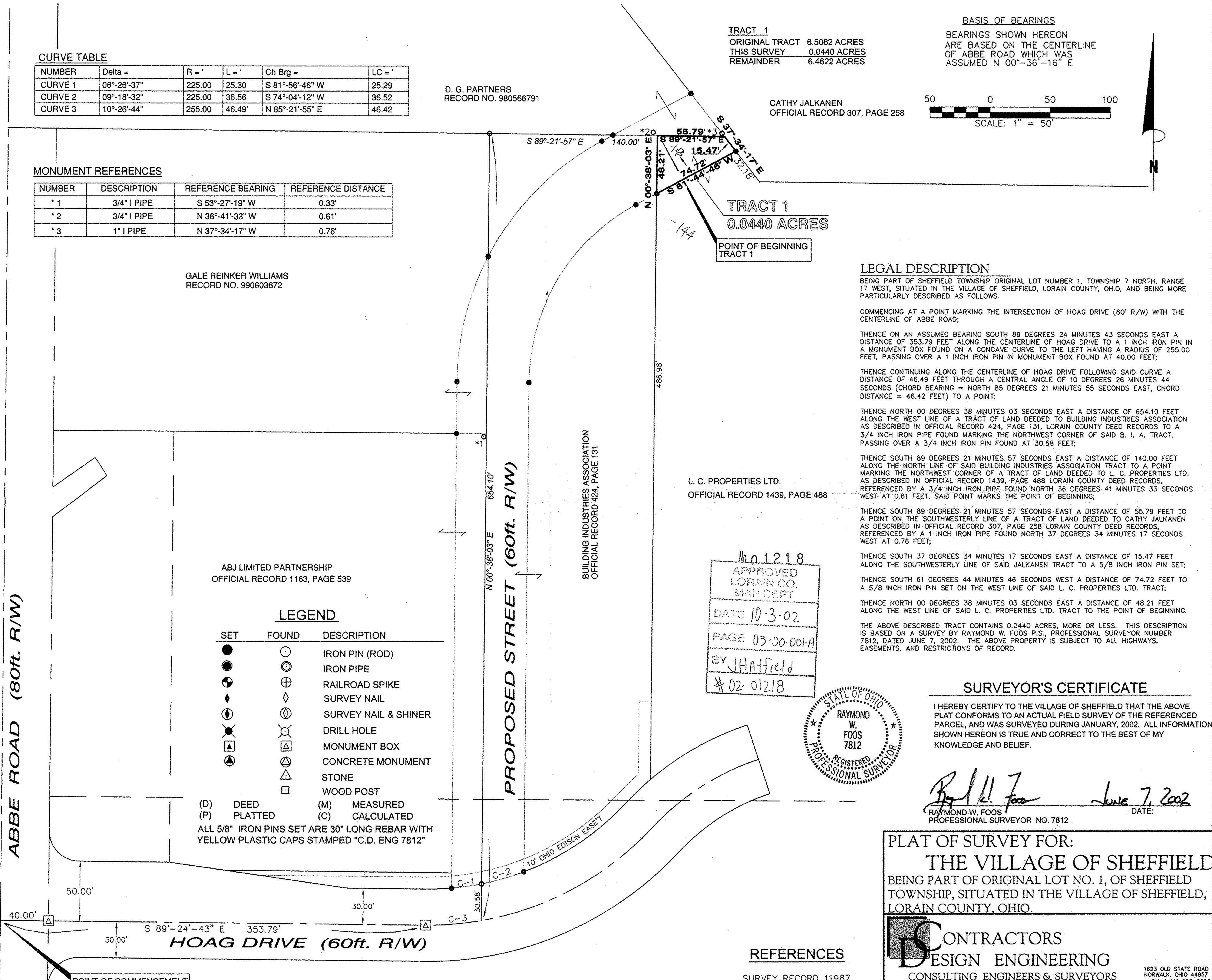

LEGAL DESCRIPTION

BEING PART OF SHEFFIELD TOWNSHIP ORIGINAL LOT NUMBER 1, TOWNSHIP 7 NORTH, RANGE 17 WEST, SITUATED IN THE VILLAGE OF SHEFFIELD, LORAIN COUNTY, OHIO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS.

COMMENCING AT A POINT MARKING THE INTERSECTION OF HOAG DRIVE (60' R/W) WITH THE CENTERLINE OF ABBE ROAD;

THENCE ON AN ASSUMED BEARING SOUTH 89 DEGREES 24 MINUTES 43 SECONDS EAST A DISTANCE OF 353.79 FEET ALONG THE CENTERLINE OF HOAG DRIVE TO A 1 INCH IRON PIN IN A MONUMENT BOX FOUND ON A CONCAVE CURVE TO THE LEFT HAVING A RADIUS OF 255.00 FEET, PASSING OVER A 1 INCH IRON PIN IN MONUMENT BOX FOUND AT 40.00 FEET;

THENCE CONTINUING ALONG THE CENTERLINE OF HOAG DRIVE FOLLOWING SAID CURVE A DISTANCE OF 46.49 FEET THROUGH A CENTRAL ANGLE OF 10 DEGREES 26 MINUTES 44 SECONDS (CHORD BEARING = NORTH 85 DEGREES 21 MINUTES 55 SECONDS EAST, CHORD DISTANCE = 46.42 FEET) TO A POINT;

THENCE NORTH 00 DEGREES 38 MINUTES 03 SECONDS EAST A DISTANCE OF 654.10 FEET ALONG THE WEST LINE OF A TRACT OF LAND DEEDED TO BUILDING INDUSTRIES ASSOCIATION AS DESCRIBED IN OFFICIAL RECORD 424, PAGE 131, LORAIN COUNTY DEED RECORDS TO A 3/4 INCH IRON PIPE FOUND MARKING THE NORTHWEST CORNER OF SAID B. I. A. TRACT, PASSING OVER A 3/4 INCH IRON PIPE FOUND NORTH 37 DEGREES 34 MINUTES 17 SECONDS WEST AT 0.61 FEET, SAID POINT MARKS THE POINT OF BEGINNING;

THENCE SOUTH 89 DEGREES 21 MINUTES 57 SECONDS EAST A DISTANCE OF 140.00 FEET ALONG THE NORTH LINE OF SAID BUILDING INDUSTRIES ASSOCIATION TRACT TO A POINT MARKING THE NORTHWEST CORNER OF A TRACT OF LAND DEEDED TO L. C. PROPERTIES LTD. AS DESCRIBED IN OFFICIAL RECORD 1439, PAGE 488 LORAIN COUNTY DEED RECORDS, REFERENCED BY A 3/4 INCH IRON PIPE FOUND NORTH 36 DEGREES 41 MINUTES 33 SECONDS WEST AT 0.61 FEET, SAID POINT MARKS THE POINT OF BEGINNING;

THENCE SOUTH 89 DEGREES 21 MINUTES 57 SECONDS EAST A DISTANCE OF 55.79 FEET TO A POINT ON THE SOUTHWESTERLY LINE OF A TRACT OF LAND DEEDED TO CATHY JALKANEN AS DESCRIBED IN OFFICIAL RECORD 307, PAGE 258 LORAIN COUNTY DEED RECORDS, REFERENCED BY A 1 INCH IRON PIPE FOUND NORTH 37 DEGREES 34 MINUTES 17 SECONDS WEST AT 0.76 FEET;

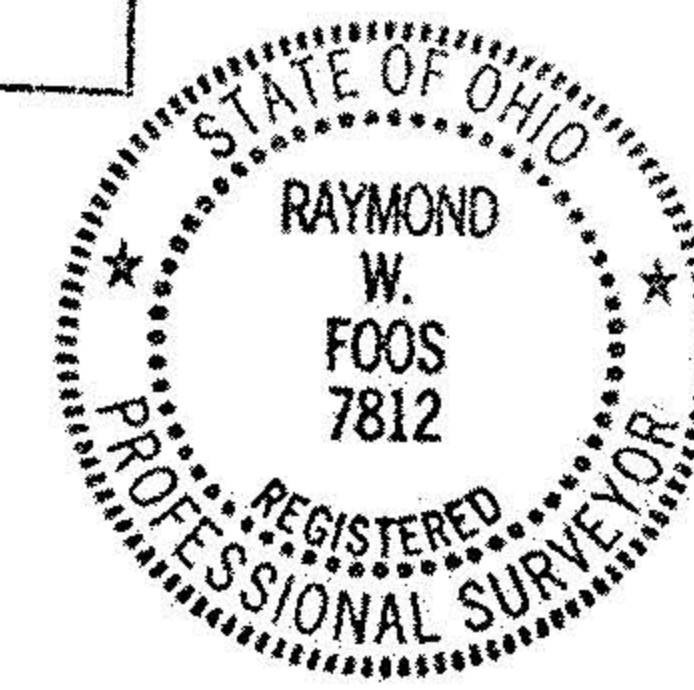
