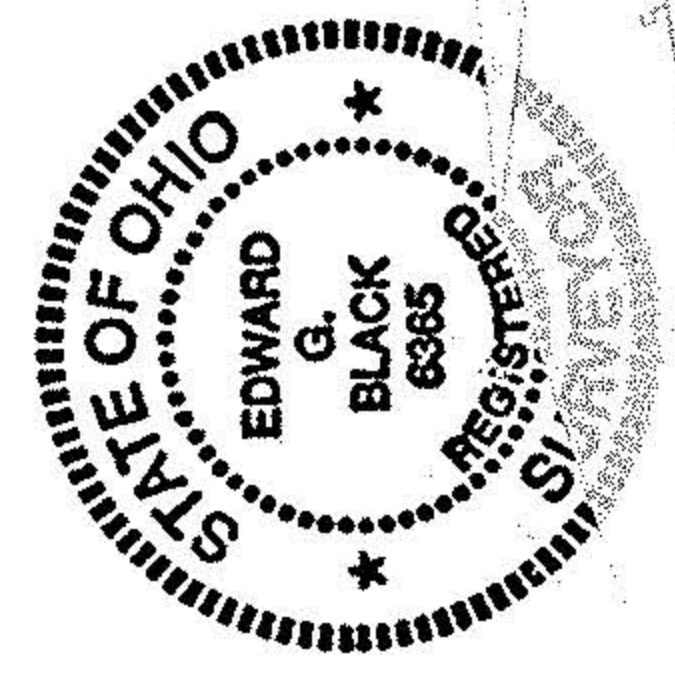

 COMMENCING AT A SURVEY NAIL SET IN THE INTERSECTION OF THE SOUTH CENTERLINE OF STATE ROUTE 58 AND THE WEST CENTERLINE OF STEWART ROAD; THENCE SOUTH 01 DEG. - 04 MIN. - 44 SEC. - EAST AND ALONG THE CENTER OF SAID STATE ROUTE 58 A DISTANCE OF THREE HUNDRED FIFTY AND FOURTEEN HUNDREDTHS (350.14) FEET TO A SURVEY NAIL SET AND THE PLACE OF BEGINNING, SAID NAIL BEING REFERENCED BY AN IRON REBAR WITH CAP SET SOUTH - 88 DEG. - 36 MIN. - 19 SEC. - WEST AND AT A DISTANCE OF (30.00) FEET;
